ALLERGY AWARE POLICY

Allergy Aware Policy 1.2 Page **2** of **5**

Due to an increasing number of students with allergies it is imperative that we promote allergy awareness in our College community.

This is particularly relevant to students whose allergies cause an **Anaphylactic** reaction. This a life threatening reaction which can cause death by suffocation within minutes of a reaction commencing. Anaphylactic reactions are frequently caused by nuts eg: peanuts/cashew nuts but may link to eggs, dairy products and bee stings as well as latex balloons and dogs.

At Kingsway Christian College we promote awareness by:

- 1. Provide information (Appendix 1) to the College community via
 - Newsletter articles
 - Parent Meetings/Class letters
- 2. Year levels with students with anaphylactic allergies will:
 - Have regular (once per term) talks on the allergy and the need not to share food, to wash hands before and after eating and the dangers of bringing nut products to school
 - Send home a letter by parents of students with allergies where provided
- 3. Teachers with allergy students will:
 - Monitor any food in the classroom eg: cooking, "birthday treats" provided by parents or class parties
 - Establish class rules on:
 - Not sharing food
 - Washing hands before and after eating
 - Cleaning up food spillages
 - Plan to ensure relief staff are aware of students with anaphylactic allergies, their emergency medical plan and the location of the Epi-pen
 - ➤ Plan for excursions/sport etc to access Epi-pen/emergency plan
- 4. The College will:
 - Provide training in the use of Epi-pens to staff in the year levels with anaphylactic students
 - ➤ With the parents, agree on a Medical Emergency Response Plan for each anaphylactic student
- 5. Parents of anaphylactic students will:

- Ensure the Medical Emergency Response Plan is completed and kept up-to-date
 provide copies for the classroom and the Health Centre
- Provide a current photo of the child if requested
- Ensure that Epi-pens and/or medication provided is:
 - Clearly labelled with the child's name, year, and room number and dosage required
 - Has a current use-by date
- ➤ Will be invited to send a personal letter home to the class parents explaining their child's allergy needs.

We have a number of students in the school with severe life threatening allergies (Anaphylactic reaction) to products, particularly nuts and eggs, latex balloons and dogs.

An anaphylactic reaction causes shock, suffocation and death within minutes of the allergy reaction commencing if not treated immediately.

These life threatening reactions can be generated by simply touching a surface that has a nut product on it or entering a room where balloons have been previously.

We are seeking your support in creating a safer environment by:

- Not providing nut products at school such as peanut paste or Nutella sandwiches or snack bars with nuts, egg and mayonnaise sandwiches and boiled eggs
- Encouraging your child to not share or swap their food or drink bottles with others
- Encouraging your child to wash their hands before and after eating
- ➤ When having other children to play or for a party be aware that they may allergies, including anaphylactic reactions. Plan for any dietary needs and medication in discussion with the relevant parent
- ➤ Not bringing latex balloons to school, foil balloons are acceptable but not latex balloons.
- Not bringing dogs onto the school property.
